In order to maximize benefits, Shaanxi Future Energy Chemicals Company Limited has optimize its production process, and has no longer produce crude liquid wax and stabilized light hydrocarbons from the end of the third quarter of 2022, but instead produce diesel, naphtha and other chemical products.*
